



Early Partial / Lump Sum Repayment of Loan under Non-means-tested Loan Scheme (NLS)

I understand and agree that my request will be processed according to the following conditions:

- For early partial repayment, the repayment amount shall not be less than an amount determined by the Student Finance Office (“SFO”) (currently set at HK\$5,000.00) or the total of one repayment instalment plus the remaining study interest already accrued before commencement of the repayment, whichever is greater.
- Interest of early repayment is calculated as follows:

Loan Account Status	Early Lump Sum Repayment Interest Cut-off Date	Early Partial Repayment Interest Cut-off Date
Before commencement of repayment	Preceding day of the date of request	Preceding day of the date of request
During the repayment period	Preceding day of the date of request	Preceding day of the due date of the forthcoming instalment

- For request by mail, the postmark date will be regarded as the request date. For proper delivery of the mail items to SFO, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure that the mail items bear sufficient postage with return address before mailing. Underpaid mail items will be returned to the senders (with return address) or disposed of (without return address) by the Hongkong Post. For request by fax, email or via the “SFO E-link” online platform, the date received by SFO will be regarded as the date of request. Normally you have to settle the “Early Partial / Lump Sum Repayment Demand Note” in full within 14 days from its issue date.
- The early repayment demand note will be posted to your correspondence address. If you would like to confirm receipt of your request, or you do not receive the demand note by post 14 days after your request, please contact our staff of the Student Loan Unit at 2150 6211 or 2150 6212. Otherwise, SFO will assume that the demand note has been received by you.
- If repayment has not been made duly, you will be required to repay to the Government of the Hong Kong Special Administrative Region the overdue amount together with overdue interest.
- If the above loan account(s) have been granted approval for deferment of loan repayment, the period of deferment would be shortened accordingly. You would have to submit a new application if you wish to defer loan repayment for the remaining instalment(s) of the above loan account(s). All applications for deferment of loan repayment will be considered on individual merits.
- If the above loan account(s) are currently under application for deferment of loan repayment, the deferment application would be cancelled.
